Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Classi X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the nonsponsoring of the candidates. Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters The Manger and the Principal of the school shall be jointly responsible for the authenticity of the 16 online/offline documents/ information/data submitted by the School to the Board.
